



VISION MULTI ACADEMY TRUST: PROPOSAL TO MAKE A SIGNIFICANT CHANGE TO AN OPEN ACADEMY

This proposal is published in compliance with the Department for Education 'Making significant changes to an open academy. Departmental guidance for all types of academy trust' January 2022.

Proposal to:

To change the lower age limit at **Higher Lane Primary School** by 1 year to incorporate Nursery Provision into the school, moving the age range from 4-11 to 3-11. This will replace Stand Pre-school who currently operate within the school building. Stand Pre-school are in agreement with the proposal.

The capacity at the school will increase by 28-30 pupils.

The proposer is Vision Multi Academy Trust (Higher Lane Primary School).

Alteration description

Higher Lane Primary School currently provides mainstream primary school provision for children aged 4-11 years with the addition of a 12 place Resourced Provision to open on 1 January 2024.

Implementation:

The proposal is to add Nursery Provision to the school altering the age range to 3-11 years.

The proposal will be implemented by Vision Multi Academy Trust (Higher Lane Primary School).

Impact on other Educational Institutions within the area:

There is expected to be no impact on other schools in the area.

Stand Pre-school currently rent space in the school and provide pre-school provision; the change in age range will replace Stand Pre-school.

Additional Site:

No additional site is required.

Objectives:

The key objective of this proposal is to provide educational provision for 3 year old children, changing the school's age range to 3-11 years.

Impact on other Educational Institutions in the area:

There is not expected to be any impact on other educational institutions in the area, as the sufficiency levels will remain unaffected.

Consultation:

Statutory requirements to consult in relation to this proposal are being complied with as per the Department for Education 'Making significant changes to an open academy and closure by mutual agreement, Departmental guidance for all types of academy trust.' January 2022.

There are no planned associated project costs.

Age Range:

The age range of the academy will change to 3-11 year old children to include Nursery provision.

Sufficiency will remain unaffected.
